

ALLOWABLE USE POLICY

1. PREAMBLE

1.1. For the purpose of this Allowable Use Policy «We» means **NomadTraff** «Website» means **www.nomadtraff.com**.

1.2. This Allowable Use Policy applies to all users and visitors website.

1.3. By entering website you accept and agree to comply with Allowable Use Policy.

2. WEBSITE ALLOWABLE USE

2.1. You are obligated to use website only for lawful purposes.

2.2. You are obligated not take the actions which:

- In any way duplicate, reproduce, resell or copy any part of website in contravention of the provisions of Terms and Conditions and Allowable Use Policy;
- In any way is unlawful or fraudulent or has any unlawful or fraudulent purpose or effect;
- In any way breaches any applicable local, national, or international law or regulation;
- In any way harm or attempt to harm minors;
- In any way procure or transmit the sending of any unsolicited or unauthorized advertising or promotional material or any other form of similar solicitation;
- In any way send, transmit any data, or upload any material that contains viruses, Trojan horses, worms, time bombs, keystroke loggers, spyware, adware, or any other harmful programs or similar computer code designed to adversely affect the operation of any computer software or hardware knowingly;

- In any way make access possible without authority, interfere with, damage, or disrupt:

 - Any part of our site;
 - Any equipment, network, or software owned or used by any third party.

3. AMENDMENTS TO THE ALLOWABLE USE POLICY

3.1. At any time we have the right to revise Allowable Use Policy by amending this page.

3.2. You shall take responsibility to check website and this page from time to time to be aware of any possible amendments.

3.3. Take a notice that some Allowable Use Policy clauses may also be amended by provisions or notices published elsewhere on website.

4. SUSPENSION AND TERMINATION

4.1. You understand and agree that failure to comply with the Allowable Use Policy constitutes a material breach of Terms and Conditions.

4.2. We have the right to determine If the breach of the Allowable Use Policy has been through your use of website, at our discretion.

4.3. In such case we have the right to take action as we deem appropriate, namely but not limited to;

- B. Disclosure of such information to law enforcement authorities as we reasonably feel is necessary;
- C. Legal proceedings against you for reimbursement of all costs on an indemnity basis (including, but not limited to reasonable administrative and legal costs) resulting from the breach;
- D. Temporary, immediate or permanent withdrawal of your right to use website;
- E. Immediate, temporary, or permanent removal of any posting or material uploaded by you to website;
- F. Further legal action against you.

4.4. You understand and agree that we exclude liability for actions taken in response to breaches of Allowable Use Policy. The responses described by Allowable Use Policy are not limited, and we have the right to take any other action we reasonably deem appropriate.

5. CONTENT STANDARDS

5.1. Content Standards shall apply to all material you may contribute to website and any interactive services associated with it.

5.2. Material you may contribute shall not:

- A. Contain any material which is obscene, offensive, hateful, or inflammatory;
- B. Contain any material which is defamatory to any person;
- C. Promote violence;
- D. Promote sexually explicit material;
- E. Promote discrimination based on race, sex, religion, nationality, disability, sexual orientation, or age;
- F. Be threatening, abusive, invade another's privacy, cause annoyance, inconvenience, or needless anxiety;
- G. Be used to impersonate any person or misrepresent your identity or affiliation with any person;
- H. Be made in breach of any legal duty owed to a third party, such as a contractual duty or a duty of confidence;
- I. Be likely to deceive any person;
- J. Infringe any copyright, database right, or trademark of any other person;
- K. Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse;

- L. Be likely to harass, upset, embarrass, alarm, or annoy any other person;
- M. Give the impression that they emanate from us, if this is not the case;
- N. Promote any illegal activity.

6. INTERACTIVE SERVICES

6.1. We may provide interactive services on website from time to time, including, but not limited to:

- A. Bulletin boards;
- B. Chat rooms;
- C. Blog comment boards;
- D. Forums.

6.2. Where we provide any interactive service, we will provide all the information on the kind of offered service, If it is moderated, and what form of moderation is used (including If it is technical or human).

6.3. We will provide you with a means of contacting the moderator when we do moderate the interactive service in case a concern or difficulty arise.

6.4. We usually do our best to demonstrate any possible risks for users from third parties when they use any interactive service provided on website.
