

PRIVACY POLICY

1. PREAMBLE

1.1. For the purpose of this Privacy Policy, «We» means **NomadTraff**.

1.2. Our Privacy Policy describes our collection, use, disclosure, and protection of your information when you use www.nomadtraff.com (hereinafter referred to “Website”).

1.3. By using website you agree and accept Privacy Policy. It means your consent to collect, disclose, protect and use your personal data by us as described in Privacy Policy.

1.4. We have the right to amend Privacy Policy from time to time. We may post any changes to website. Your continued use of website after the posting of any changes mean you accept all the amendments.

1.5. Be aware that Privacy Policy does not apply to information that you may submit to us offline or to third-party websites and mobile applications that may link to the website or be linked to on the website.

1.6. Be aware that we are not responsible for the actions or privacy practices of third-party websites and applications. We ask you to consult such websites and applications directly to understand their privacy practices.

1.7. In case you do not agree with Privacy Policy we ask you not to use website.

2. WHAT KIND OF YOUR INFORMATION WE MAY COLLECT

2.1. We process, retain and collect your data and any devices you may use when you interact with website and in other ways, namely.

- **Data we collect automatically:** We receive and store data whenever you interact with website. Website uses cookies, tags, and other tracking technologies to help enable us to enhance your online browsing experience and market our services. This information includes computer and connection information such as statistics on your page views, traffic to and from our Websites, referral URLs, your IP address, and device identifiers. This information also may include your browsing history and your web log information.
- **Data About Your Interaction With Our Websites:** We collect information about your use of our Websites, such as the pages you view and other interactions you have.
- **Location Information:** When you interact with website, we may receive information about your general location, including a unique identifier for your device. Location information allows us to provide location-based services such as advertising, search results, and other personalized content. Some services or features may not function properly without this information.
- **Information You Give Us:** We receive and store the information you enter on our Website or give us in any other way, including your name, mailing address, phone number, e-mail address, social profile, and portfolio.
- **Information From Social Media:** When you interact with website on a social media platform, we may collect the personal information that you make available to us on that page, including your account ID or username and other information of your posts.

3. ACCESSING AND MODIFYING YOUR INFORMATION

3.1. When like to request modification, access, correction, or deletion of provided personal information do not hesitate to contact us.

3.2. Be aware that we may be unable to delete your personal information without deleting your user account.

3.3 You are not allowed to examine the personal information of any other person or entity.

3.4. You are required to provide personal information to verify your identity before accessing any records containing information about you.

3.5. We have the right not to take a request to change or delete personal information in case we believe this could violate any law or legal requirement or cause the information to be incorrect.

4. THE WAY WE MAY SHARE YOUR INFORMATION WITH OTHERS

4.1. We may share your personal information with third parties in a few ways.

4.2. We may share information that does not personally specifically and identifies you, such as:

- de-identified data;
- device identifiers;
- aggregate information;
- other unique identifiers with third parties.

4.3. We engage third-party service providers to perform functions on our behalf, such as;

- hosting;
- technical integration;
- content management
- content syndication;
- marketing;
- analytics;
- customer service.

These third parties may have access to your personal information when needed to perform their functions.

4.4. We may share information that personally identifies you with business partners or affiliates who provide products and services that we think you may be interested in.

4.5. We may also use or disclose your personal information if required to do so by law or on the good-faith belief that such action is necessary to:

- protect and defend our rights or property, the website or our users;
- conform to applicable law or comply with legal process served on us or website;

- act to protect the personal safety of us, users of the website or the public.

4.6. We may change our ownership or corporate organization while providing the website. We may transfer to another entity or its affiliates or service providers some or all information about you in connection with, or during negotiations of, any merger, acquisition, sale of assets, or any line of business, change in ownership, control, or financing transaction. Under such circumstances, we will request the acquiring party follow the practices described in Privacy Policy concerning the previously collected information. Nevertheless, we cannot promise that an acquiring party or the merged entity will have the same privacy practices or treat your information the same as described in this Privacy Policy.

5. HOW WE MAY USE YOUR INFORMATION

5.1 We use your information to help us personalize and continually improve your experience with website, including, but not limited to:

- analyzing and compiling trends and statistics;
- fulfilling requests for information;
- communication with you.

5.2. We also may use your information to:

- Send you newsletters, marketing, or other materials;
- Provide, maintain, and improve the website for internal or other business purposes;
- Fulfill your requests for information and communicate with you;
- Track and evaluate the use of the website, including building user profiles;
- Detect, investigate, and prevent activities that may violate our policies or be fraudulent or illegal; optimize or improve website, services, and operations;
- Perform statistical, demographic, and marketing analyses of users of the Website and their usage patterns.

5.3. We may use the information from one portion of the Website on other portions of the Website, and we may combine information gathered from multiple portions of the Web Website sites into a single record.

5.4. We also may use or combine information that we collect offline, or we collect or receive from third-party sources for many reasons, including to enhance, expand, and check the accuracy of our records.

6. HOW WE SECURE YOUR INFORMATION

6.1. We take all possible and reasonable security measures to help protect the personal information collected through Website.

6.3. We ask you to understand that we try our best to safeguard your personal information once we receive it. At the same time no data transmission over the Internet or any other public network can be guaranteed to be 100% secure.

6.4. You can help protect the privacy of your information by using encryption and other techniques to prevent unauthorized interception of your personal information.

6.5. You are responsible for the security of any personal information that you transmit to us or that you view, download, or otherwise access when using unencrypted, public, or otherwise unsecured networks.

7. HOW YOUR INFORMATION IS USED AND SHARED BY YOUR CHOICE

7.1 It is possible for you to choose the information you provide and how we use your information.

7.2. These choices and any related consequences are:

- **Business Partners and Affiliates:** You can opt out of the information we share with our business partners and affiliates by contacting us;
- **Marketing E-mails:** When you provide us with an e-mail address, that constitutes your express acknowledgment that we may use your e-mail address to communicate with you about our services and select messages from our partners or affiliates. While you cannot opt out of receiving notifications and other communications regarding your account or your transactions, you can opt out of receiving promotional and other marketing e-mails from us by using the “unsubscribe” link in our marketing e-mails.

8 TRACKING TECHNOLOGY, COOKIES AND INTEREST-BASED ADVERTISING

8.1. We use tracking technologies like web beacons, cookies and similar in order to:

- record your preferences;
- track the use of Website;
- expose you to our online advertisements.

8.2. We may also use these technologies to:

- improve the Website;
- monitor traffic;
- make the Website easier to use and more relevant.

8.3. We may partner with third-party advertising companies that also use these tracking tools to provide advertisements on Website or other websites. These third parties may use these technologies to collect information about you when you use the Website. They may collect information about your online activities over time and across different websites and other online services. They may also use persistent identifiers to track your Internet usage across other websites in their networks beyond the Websites. They may use this information to provide you with interest-based advertising or other targeted content. While we do not knowingly provide these entities with information that personally identifies you, such third parties may. Sufficient data from other sources unknown to us would be able to identify you.

8.5. Most web browsers automatically accept cookies, but if you prefer, you can usually modify your browser setting to disable or reject cookies. If you delete your cookies or set your browser to decline cookies, some features of the Website may not work or may not work as designed.

8.6. Some content or applications on the Websites may be served by unaffiliated third parties. We do not control these third-party tracking technologies or how they may be used. We are not responsible for the content or privacy practices on any website not operated by us to which our Websites link or that link to our Websites.

8.7. Your browser or device may include “Do Not Track” functionality. Our information collection, disclosure practices, and the choices we provide to visitors will continue to operate as described in this Privacy Statement, whether or not a Do Not Track signal is received.

8.8. Please note that opting out of advertising network services does not mean that you will not receive our advertising, nor will it prevent the reception of interest-based advertising from third parties that do not participate in these programs. It will, however, exclude you from interest-based advertising conducted through participating networks, as provided by their policies and choice mechanisms.

8.9. We use Google Analytics, a web analytics service provided by Google, Inc., and other online analytics services on Website. These analytic services use cookies or other tracking technologies to help us analyze how users interact with and use the Websites, compile reports on the Website’s activity, and provide other services related to the Websites’ activity and usage. These technologies may collect information such as your IP address, time of visit, whether you are a return visitor, any referring website, and other information. The Websites do not use Google Analytics to gather the information that personally identifies you.

9. IMPORTANT INFORMATION ON MINORS

9.1. Websites are intended for users ages 13 and older only.

9.2. We will not collect or use any personal information from children knowingly that we know to be under the age of 13.

9.3. If we become aware of personal information in our database collected from a child under 13, we will delete such information.
